Age Group Chair Report

Ladder of Success/ Ladder of Success Shirts

- The preliminary short course Ladder of Success was posted on the Gulf website on May 1, and corrections were due by May 18th. We generated the report from SWIMS. Most of the inquiries were related to team status. If a swimmer's time was from a high school meet, the swimmer's team affiliation was UNAT in the SWIMS database, and therefore UNAT on the Ladder of Success report.
- David Howard will design and print the Ladder of Success shirts. Allison will work on distribution in June.

2009 Zone Team

- Emily Milak has agreed to be the Head Coach for the 2009 Gulf Zone Team.
- We will post the swimmer and coach applications on the Gulf website this week.
- Qualifying standards remain the same. A swimmer must have at least one AAA time to apply for the team.
- The selection process is similar to last year, but we moved the deadlines up due to Zones and TAGS being on the same date. The selection procedure, which was reported at the October House of Delegates Meeting and passed at the November Board of Directors Meeting is the following:
 - Applicants must have a least one AAA time to apply.
 - For 11-12 swimmers, the fastest applicant in the 50 fly, 50 back, 50 breast, and 50 free will automatically make the team.
 - For 13-14 and senior swimmers, the fastest applicant in the 100 fly, 100 back, 100 breast, and 50 free will automatically make the team.
 - We will fill the remaining spots for each age group by selecting the swimmers with the highest combined power point score of his or her top two swims. Events considered will be events offered for the swimmer's specific age group at Zones.
 - Only times swum from April 1, 2009 to June 28, 2009 are eligible for consideration.
 - All applications and deposits will be due on June 20, 2009. Swimmers are responsible for contacting the head coach with updated times swum from June 20- June 28. The deadline for submission of those times is 10:00 AM on June 29, 2009.
 - Swimmers not having an AAA time before June 20, but swim an AAA time or faster after the application deadline may still submit an application by 10:00 AM on June 29, 2009. This extension only applies to swimmers achieving his or her first AAA LCM time for the 2009 season.
 - The final team will be named on June 29, 2009.
 - The deadline for disabled athletes is also June 15, 2009.
